ORDER:

In the reference first cited, the University has granted the Provisional Affiliation order to **Sri Ramakrishna Dental College & Hospital, SNR College Road, Coimbatore- 641 006**, for conducting the BDS Degree Course with an annual intake of 60 seats from the Academic Year 2000-2001.

2. Subsequently in the reference 2nd cited, the Provisional Affiliation order issued to the above Institution for increase of an annual intake from 60 to 100 seats from the academic year 2007-2008.

- 3. In the reference 4th cited, Sri Ramakrishna Dental College & Hospital, Coimbatore has obtained the recognition order from the Government of India, Ministry of Health and Family Welfare, New Delhi to conduct for BDS Degree Course.
- 4. As per the Governing Council Resolution No.197 (45) dated.12.05.2010, the above institution was classified under "Once in three years" category. Hence, the Institution was inspected for grant of Continuance of Provisional Affiliation for the academic year 2017-2018. In the reference 6th cited, the Affiliation Sub-Committee of this University has recommended to the Governing Council to grant Continuance of Provisional Affiliation for the academic years 2017-2018, 2018-2019 & 2019-2020, after collecting the necessary fees and obtaining an annual Undertaking regarding teaching and infrastructural facilities. In the reference 7th cited, the Governing Council has approved the recommendations of the Affiliation Sub-Committee.
- 5. The Chairman, **Sri Ramakrishna Dental College & Hospital, Coimbatore** has submitted an undertaking in Non Judicial stamp paper of the value of INR Rs.100/- that the institution possess adequate infrastructural, teaching and other facilities as prescribed by this University for an annual intake of 100 seats for the academic year 2019-2020.
- 6. The University grants Continuance of Provisional Affiliation to Sri Ramakrishna Dental College & Hospital, Coimbatore for conducting B.D.S Degree Course for the academic year 2019-2020 as indicated below subject to the usual conditions already intimated in the Provisional Affiliation orders of this University.
