ORDER:

In the reference first cited, the University has granted the Provisional Affiliation order to **Sri Ramakrishna Dental College & Hospital, SNR College Road, Coimbatore- 641 006**, for conducting the BDS Degree Course with an annual intake of 60 seats from the Academic Year **2000-2001**.

2. Subsequently in the reference 2nd cited, the Provisional Affiliation order issued to the above Institution for increase of an annual intake from 60 to 100 seats from the academic year 2007-2008.

3. In the reference 3rd cited, **Sri Ramakrishna Dental College & Hospital, Coimbatore** has obtained the recognition order from the Under Secretary to Government of India, Dental Council of India/ Ministry of Health and Family Welfare, New Delhi to conduct BDS Degree Course.

4. In the reference 4th cited, the University has granted the Continuance of Provisional Affiliation orders for conducting BDS Degree Course for the academic year 2019-2020. The same was approved in Resolution No. 17 passed at the 269th Governing Council meeting held on 18.06.2019.

5. The Inspection **Commission has conducted the inspection in the month of March 2020** and submitted its reports to this University, which has stated that the infrastructure, teaching staff, equipments, clinical materials and lab investigations and other facilities are adequate for an annual intake of 100 seats for the academic year 2020-2021.

6. The University grants Continuance of Provisional Affiliation to **Sri Ramakrishna Dental College & Hospital, SNR College Road, Coimbatore** for **B.D.S Degree Course** for the academic year 2020-21 **with an annual intake of 100 (One Hundred) seats**, as indicated below subject to approval of Governing Council and the usual conditions already intimated in the Provisional Affiliation Orders of this University.

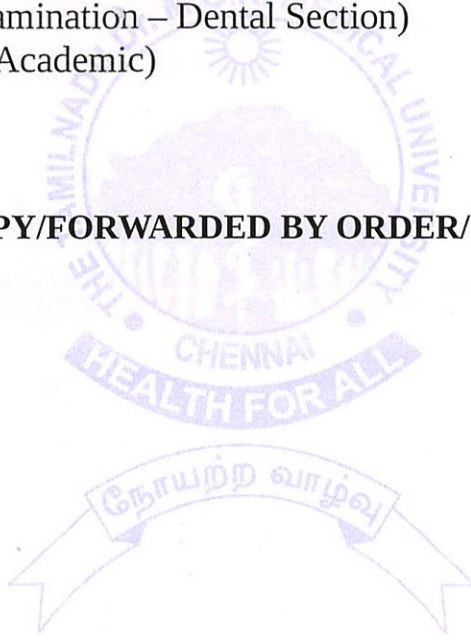
