Hence, the Secretary, Selection Comittee, Chennai has informed that NOT to admit any students in BDS & MDS Courses for the Academic Year 2018-2019.

Subsequently in the referene 8th cited, the Under Secretary to the Government of India, Ministry of Helath & Family Welfare, Dental Education Section, New Delhi, has stated that, recommended to the Central Government to revoke its earlier stoppage order for the academi year 2018-2019 with based on the DCI recommendations that the time schedule and specifically the last date for granting of permission (i.e) 31.05.2018 for the academic year 2018-2019 would not be applicable to this case it is a recognized college. Only the last date of admission (i.e) 15.09.2018 would be applicable for the academic session 2018-2019.
