2. In the reference 3rd cited, the University has granted the Continuance of Provisional Affiliation orders for conducting MDS Degree Course for the above said specialities for the academic year 2019-2020. The same was approved in Resolution No. 16 passed at the 269th Governing Council meeting held on 18.06.2019.

3. The Inspection Commission has conducted the inspection in the month of February to March 2020 and submitted its reports to this University, which has stated that the infrastructure,

teaching staff, equipments, clinical materials and lab investigations and other facilities are adequate for MDS Degree Course for the academic year 2020-2021.
