












Over view of Management

Qualification and admission criteria: Admission of candidates is based on the Tamilnadu medical selection committee online allotment list published).


Eligibility Criteria: NEET UG – 2022 qualified candidates (both State Government and Management Category) who have been allotted to Sri Ramakrishna Dental College and Hospital by the Tamilnadu medical selection committee are eligible to report for admissions for the academic year 2022. It is mandatory to submit copy of Allotment order, Aadhaar card and Pan Card (fee paid account linked) at the time of admission.

SELECION CRITERIA



Candidates are advised to regularly visit the DME/TN health website for latest notifications regarding counselling schedule / reschedules / counselling scheme and other latest information after NEET-UG 2022 results.

- *Any 4 of the Advanced Programs on 40 Hours Rotary endodontics, Aesthetic Dentistry, Implantology, CAD CAM Dentistry, Laser Dentistry, Ceramic technology, Sedation Dentistry can be chosen by students during the program.
- Candidates must remit the Course fees at the time of reporting by RTGS / NEFT* Request of extension of time for fee payment will not be considered. DD/Cheque/Cash payment will not be accepted/entertained at all.
- Other fee is collected in facilitation of the above courses to give the student ready for practice above the curriculum prescribed as value added programs during the course of study.

Hostel

The college has well-furnished and well-ventilated separate boys' hostel in which there are totally 21 rooms (5 individual rooms) and in girls' hostel in which there are totally 116 rooms (30 individual rooms). The In- House warden, Assistant Warden, Supervisor and Helpers are there to take care of inmates. Hostel mess provides delicious, hygienic and homely food which serves both vegetarian and non-vegetarian in the dining hall. Separate laundry and washing provision for clothes are there. Inmates are provided with Indoor and Outdoor sports facilities, Recreation room and Fire safety measures. First aids and 24 hours

emergency medical facilities are there for inmates. Hostel Rules and Guidelines will be provided to all Students at the time of admission. Students are requested to sign the terms and conditions provided in the Rules and handover to Admission Office at the time of admission or can <u>https://srdch.ac.in/wp-content/uploads/2023/08/hostel-2.pdf</u>

Important points during selection / choice locking process:

- The fee structure for Self-financing Medical and Dental Colleges will be adopted as fixed by the Fee Committee constituted by the Government of Tamil Nadu during the academic year 2022-2023 and will be notified in the website at the time of counseling.
- Selected candidates have to pay entire Tuition fee, Special fee etc., at the time of downloading the allotment order through online via RTGS / NEFT Check the validity of the Debit card and bank balance keep it ready while logging on to the website for submitting application form. Candidates should enter the information asked for and make payment through Debit card.
- Detailed information regarding Scholarship, Fee Concession, Hostel Facilities, Transport, Mess charges etc., can be obtained from the Head of the Institution of the Self-Financing Medical / Dental College in which the candidate joins.
- After receipt of the joining report from the Deans of the respective colleges, the Tuition Fee
 amount will be transferred to the concerned colleges. This fee is Non-refundable. If the
 candidate does not join the Institution, he / she has to forfeit the amount paid while getting the
 provisional allotment order and that allotted seat will automatically stand cancelled. The
 candidates who discontinue the course will also forfeit the Tuition Fee paid at the time of
 counselling.
- The selected candidates should produce all the original documents at the time of admission to the Deans / Principals of the concerned Medical / Dental Colleges. The Selection will be cancelled if the candidates do not produce the original documents at the time of admission.

Fee Payments

- 1. Candidates are requested to remit the first-year fees at the time of admission as mentioned.
- 2. From second year to final year tuition fees, other fees, hostel and mess fees should be paid within the stipulated date informed by the administrative office.
- 3. Failure to make the fee payment within the specified dates will turn to loss of attendance and also fine will be charged from the last day of fee remittance stipulated by the Institution. Fine is INR 250/- per day.
- 4. Upon failure of fee payment, the stipend offered for UG Students will be withheld until all fee dues are cleared (if any).
- 5. A student will only be permitted to attend the University Examination after all fee dues are cleared.
