

- Keep waste ready by 10 am, packed in bins(organic) (to be kept covered) and bags(dry waste) (packed and tied), at the pickup point, as close to the gate as possible. All waste will be packed in bins and bags as required. Pickup point should be within the premises.
- Loading help to be given, to load waste, in the vehicle.
- Waste that is generated and segregated by residents must not be disposed outside the premises.

Waste Pickup Clause

Organic waste – food, vegetable peels, fruits & flowers, such waste has to be stored in green bins.

Dry waste - plastic, papers, wood, metal waste packed in blue bags, bottles have to be kept separately and given.

Sanitary Waste - is unhygienic and bio hazardous that cannot be recycled such as sanitary napkins, diapers, hair, blades, injection and sharp items. These wastes has to be properly wrapped and marked X, kept in red bins.

The above mentioned waste should not be mixed with one another and if found mixed will not be picked.


Financials and other terms:

1. Pickup Charges

Organic waste (60 ltr green bin) – Rs.100/- per bin plus GST. Dry waste (100 ltr white/blue bag) – Rs.50/- per bag plus GST. (From Monday through Saturday daily up to 5 bins will be loaded).

2. Approximate monthly consumption to be maintained as advance, from which daily consumption will be reduced and invoice sent.
3. The agreement can be terminated by either party on service of ONE Month's notice or on mutual agreement, once all dues from both sides have been settled. This agreement is deemed to be extended unless any request for changes.
